**AN ORDINANCE AMENDING ORDINANCE NO. 3, SERIES 2021 REGARDING THE  
SALARIES OF THE CITY CLERK AND TREASURER**

BE IT ORDAINED BY THE CITY OF WORTHINGTON HILLS THAT:

Ordinance No. 3, Series 2021 which reads as follows::

SECTION 1. The City Clerk shall be paid \$700 per month and the City Treasurer shall be paid \$700 per month effective July 1, 2024.

SHALL BE AMENDED to read as follows,

SECTION 1: The City Clerk shall be paid \$750 per month and the City Treasurer shall be paid \$750 per month effective July 1, 2024.

This Ordinance shall be become effective July 1, 2024 upon passage, approval, properly signed, and published as required by law.

PASSED AND APPROVED by the Commission after a second reading during the December 19, 2023 City Meeting pursuant to Kentucky law.
