*The meeting was called to order at 7:00 pm by Mayor Stonum with motion by Commissioner Beville and seconded by Commissioner Metcalf. The Pledge of Allegiance to the Flag of the United States was recited; followed by a moment of silent prayer.*

**Minutes:** The December 2025 minutes were brought up for approval. Motion was made by Commissioner Maupin to approve the minutes and seconded by Commissioner Metcalf. Vote was unanimous.

**Financial Report:** The December 2025 Financials had been distributed to the Commission for review and posted on COWH website prior to the City Meeting. Motion to approve was made by Commissioner Beville and seconded by Commissioner Maupin. Vote was unanimous.

**Expense Review:** The cover sheet of January invoices along with invoice copies were passed around for Commissioners to review and initial. No approval motion was needed since Commissioners had already initialed and approved

**Legal:**

- Mayor Stonum advised that the Commissioners' assignments needed to be updated. Any requests for changes? No – so Commissioner Metcalf made a motion for all Commissioners to maintain current job duties. Seconded by Commissioner Beville. Vote was unanimous.
- Mayor Stonum advised we needed to decide to maintain the current Mayor Pro-Tem who is Commissioner Metcalf. Commissioner Beville made the motion and it was seconded by Commissioner Maupin. Vote was unanimous.
- Commissioners' Salary Ordinance:
  - o Mayor Stonum did the first read. Ordinance #1 Series 2026. Would be effective January 1, 2027. Second read will possibly be at the COWH February meeting.

**Old Business:**

- Commissioner Beville is still working on the road grants. Legislature is back in session. Must present as a House Bill. Commissioner Beville reached out via email to Senator Lindsay Tichenor and Representative Tina Bojanowski to ask for approval. Voting will be in the future. \$20 million in the road fund and COWH is #6 on road needs.
- Welcome Ambassador – no change/update
- Commissioner Metcalf advised we will be using Channel 12 tonight for radio check.
- City Clerk Lush asked about the old city laptop. It had been stated that it would be used to create reports from our electronic speed signs. Mayor Stonum said that the software has not been downloaded yet.

She replied that the legislature chooses the projects and approves the funding and suggested that I reach out to my representatives.

1/15/2026 – I sent Senator Lindsey Tichenor and Representative Tina Bojanowski a copy of the application I submitted and ask them to please consider approving my funding request.

1/16/2026 – House Bill 304 was introduced and has gone to Appropriations and Revenue. I will watch the voting and let the Commission as soon as I have an answer.
